Brainstorming

Case #1: from Dusty. In-home help needed for respite care after surgery, 13 year old with a rare syndrome will have surgery in a month at Shriners, dad works 2 jobs, mom works nights, Regence BlueCross BlueShield. Shriners case manager has been contacted, applied to Steelman Foundation for emergency respite, [Regence *will* cover in-home care for palliative].

Before/after school care for students of the Kauri Sue Hamilton School and within the Jordan School District. Recommended Valley Behavioral and a Family Resource Facilitator.

Case #3: from Gina. [Utah Medicaid Benefits for Children – CHEC, UDOH](#) The Early and Periodic Screening, Diagnostic and Treatment (EPSDT) benefit provides comprehensive and preventive health care services for children under age 21 who are enrolled in Medicaid. EPSDT is a federal law that helps children on Medicaid receive medical services that are medically necessary even if they are not covered under the state's plan. EPSDT is key to ensuring that children and adolescents receive appropriate preventive, dental, mental health, and developmental, and specialty services. Many child, disability and family advocacy organizations are advocating within the state and nationally to keep this vital benefit in place for all children but especially children with special needs. medicalhomeportal.org/services/provider/23099
